MTJ GROUP LTD TEMPORARY EVENT NOTICE SUB-COMMITTEE 11th April 2024

I, Thomas Glover, am a director of MTJ Group Ltd and have worked in hospitality for the last 15 years. Along with my business partners James Glover and Michael Mason we have over 50 years' experience working in the industry. We have a wealth of experience and now operate a portfolio with 11 venues ranging from high end cocktail bars, nightclubs, and food-led pubs.

We took over the venue known as Bar 44 on 1st of November 2022 and have invested heavily in the venue, making it a venue that patrons in St Helens come to regularly and enjoy. We have never been invited in to discuss ongoing trouble at the venue or been in receipt of any warnings due to the nature of our professional operating at the venue.

Since taking over at Bar 44 we have successfully and safely applied for 52 Temporary Event Notices along with a further 27 'Special Days' allowing the venue to operate until 5AM. We have done this continuously since 2022 and it appears the venue has been operated in the exact same manner since at least 2009 which is the first TEN recorded on St Helens Public Register (Exhibit 1A).

Allowing Bar 44 to utilise it's TENs meant that it could compete with neighbouring venues in a 5AM economy, which had been created over the years with various premises across the town regularly operating until this time. Chris Kenny, Principal Licensing Officer, also confirmed in a witness statement (Exhibit 1B) that the majority of venues (58%) across the town operate until 5AM, and anywhere between 2-4 venues operate until 5AM on any particular weekend.

Given that we were (along with many other venues) operating so frequently until 5AM on a temporary basis, MTJ Group applied for a licence variation to make the operating schedule permanent, which was due to be heard in January of this year but has been adjourned until June of 2024 and it is at this point there has been a change in how Temporary Event Notices are Bar 44 at viewed.

Bar 44 applied for a temporary event notice on 1st February 2024, which was objected to by Craig Carmichael of Merseyside Police due to the high level of crime in the area and the cumulative impact policy and he believed the permitting of that TENs would undermine the licensing objective. At that point it was highlighted that Bar 44 was being targeted due to the ongoing appeal in the magistrates court however Craig Carmichael insisted that this was not the case and that TEN objections had been considered for some time by Merseyside Police and Chief Inspector Jon Smith had now collated the evidence to demonstrate that TENs between the hours of 03:00 – 05:00 were undermining the licensing objectives, and that all TENs were now being objected to, not just Bar 44. When I stated that *one* TENs had been submitted 2 days after Bar 44s, I was informed this must have been a admin error which means it was missed as it should have been refused.

I now refer you to a list of TENs (Exhibit 2A) that have been submitted in 2024 across the town centre between 01/01/2024 and 31/03/2024 which amounts to 13 Temporary Event Notices – an average of 1 per week, 3 of which have been submitted **after** our last TEN application.

This clearly highlights that what we are being told about TENs across the town is simply not true and Bar 44 is being unfairly targeted.

In 2022 St Helens was first awarded Purple Flag Status recognizing it's standards and safety for patrons between the hours of 5pm – 5am in town centres. See Exhibit 1C. This is contradictory to what we are hearing regarding high crime in the area.

In fact in January of 2024 Merseyside Police released a statement where a venue on Duke Street had it's licence revoked and included a quote by Community Sergeant Julia Harris which stated that since it's

closure there had been a reduction in crime reported across the night time economy". Exhibit 1D.

It is therefore my contention that Bar 44 is only being refused TENs because of the ongoing appeal. It is neither fair nor just, when competing properties are allowed to continue operating under the same manner. We have not received any warnings, or had any intervention on how we operate the venue since taking over however now we are being refused Temporary Event applications.

I therefore ask the sub-committee to permit the Temporary Event Notice application as submitted.

- As such, the Licensing Authority would estimate that 11 of the 19 premises with a licence until 03:00 in the town centre ward apply for extended hours, equating to 57.89%.
- 13. It is my experience that of the 19 identified premises in the town centre ward, there could be anywhere between 2 and 4 premises which operate a licence until 05:00 on a particular weekend and such applications are often made using the late TEN's procedure.
- 14. The records of the Licensing Authority show that Bar 44 applied for 6 late TEN's in 2023 for the following dates:
 - a. 29.01.2023.
 - b. 25.03.2023 and 26.03.2023.
 - c. 29.04.2023 and 30.04.2023.
 - d. 07.05.2023 and 08.05.2023.
 - e. 13.08.2023.
 - f. 10.09.2023.

I believe that the facts stated in this witness statement are true.

"We felt that a review of its licence was necessary as we received 20 reported incidences of serious crime and disorder such as assault, theft, drug use and sexual offences on the premises in the past year.

"Despite numerous attempts to engage with the licensee, continuous breaches in licensing conditions continued at the premises.

"However since its closure we have seen a positive impact over the Christmas and New Year period in the town with a reduction of incidents reported to us in the night time.


"We hope this sends a clear message to any other licensed premises that robust action will be taken when issues arise.

WITNESS STATEMENT OF JON SMITH

I, Jon Smith, will say as follows:

- I am Chief Inspector Jon Smith of Merseyside Police currently stationed at St Helens Police Station, College Street, WA10 1TG. I have been a serving police officer for over 17 years.
- 2. My role as Chief Inspector for St Helens Local Policing gives me responsibility for the delivery of operational policing across the Borough of St Helens. I am responsible for delivering policing in line with community needs, managing threat and risk, and delivering operational policing in managing any identified risks. In turn, this makes me responsible for operational policing of the St Helens Night-Time Economy ('NTE').
- I am familiar with the St Helens area. I was posted to St Helens in January 2020 as Neighbourhood Inspector and have worked within St Helens since that time. As such, I have had some responsibility for delivery of operational policing of the N.T.E. in St Helens since January 2020.
- I have experience in producing evidence in support of representations made by Merseyside Police regarding premises licence applications and variation applications, based on my local knowledge of the St Helens area.
- 5. I am aware that the premises known as 'Bar 44', located on Westfield Street, St Helens, have submitted an application for Temporary Event Notices which will entail an extension of licensing hours from 03:00hrs to 05:00hrs. It is my belief that to grant such a T.E.N. would undermine the licensing objective of the 'prevention of crime & disorder' and would add further to the cumulative impact in the area.
- Incidents of anti-social behaviour, crime and disorder are particularly prevalent within the N.T.E. and especially on Friday and Saturday night, as there are a large number of bars, pubs and nightclubs within a small area.

- 7. St Helens is a centralised town in terms of its N.T.E., with the majority of the bars, pubs and restaurants located within the Town Centre Ward. As such, the streets that contain the largest number of licensed premises tend to attract the most visitors and in turn suffer most from anti-social behaviour, crime and disorder.
- 8. Having recently reviewed crime data for St Helens, and the times and days when violent crime is at its most prevalent, it has shown quite clearly that it is during these times, in the Town Centre Ward, when there is a greater risk to residents and an increased likelihood of violence.
- The D111 policing beat, which covers Westfield Street and Bar 44, suffers from a significant number of incidents of anti-social behaviour, crime and disorder.
- 10. From my experience, these incidents include things such as public order offences, assaults, assaults with weapons and robberies, with the vast majority of these having had alcohol as a contributing factor. For the twelve months prior to the completion of this statement, there were 607 violent crimes in the D111 beat. The closest policing beat to this in the Borough of St Helens had experienced 168 less crimes, a significant difference, and that was D231 in Parr with 439. I have produced a screenshot from Merseyside Police Delphi system, which I exhibit as JS/01, which shows this data.
- 11. When considering that D111 is the beat with the most violent crime in St Helens, it is then even more significant when considering this T.E.N., that within this beat Westfield Street was the street with the highest volume of crime, having had 74 instances of violent crime over the twelve months prior to completing this statement. 32 of these crimes, equivalent to 43%, were violence with injury. Furthermore, 18 instances, the equivalent to just under 25%, took place during the hours of 03:00-05:00hrs on a Saturday and Sunday morning, which can be clearly seen as a peak in violent crime. I

have produced a further screenshot from Delphi to display this data, which I exhibit as JS/02.

- 12. Based upon my experiences of the St Helens N.T.E., it is evident that bars such as Bar 44 become busier, and that people in these premises become more intoxicated, as the night progresses. To extend hours creates a greater likelihood of increased intoxication levels, and significantly increases the likelihood of crime and anti-social behaviour. The hours of 03:00-05:00hrs can already be seen to be a peak period in violent offending, and so I would deem an increase in licensable activity to cover this time as a step that would be damaging to users of the N.T.E. and one that would put patrons and residents at greater risk.
- 13. There is a regular police presence on Westfield Street on a Friday and Saturday night due to concerns regarding potential anti-social behaviour, crime and disorder. These resources are on duty until 04:00hrs as part of their core shift patterns. From 04:00hrs onwards, there are limited resources covering the Town Centre and what remains on duty is responsible for covering the entirety of the St Helens area. These shift patterns have been created having taken into account peaks in calls for service demands and operational requirements across the Merseyside area. They are a core shift pattern and so it is clear from a policing perspective that as well as the risks to the public of increased violence, such extended operating hours also place a strain upon Police resources.
- 14. The resources referred to at paragraph 13 above are deployed on their shift pattern in line with overall force resourcing and demand requirements. Variations of shifts mean that cumulative resource levels drop at core times and it can adversely impact the force's ability to respond to contingencies that require the rapid movement of staff across Merseyside. These resources that are on duty until 04:00hrs maintain a presence on Westfield Street and the surrounding area as users of the N.T.E. slowly dissipate and gather around taxi ranks, and takeaways located on Westfield Street and

the surrounding areas, some of which hold a licence for late-night refreshment until 04:00hrs.

- To my knowledge, none of the premises located on Westfield Street currently hold a permanent alcohol licence beyond 03:00hrs.
- 16. It has been my understanding that some premises on Westfield Street have utilised T.E.N.s previously to extend their hours beyond 03:00hrs for special events. From my experience, these premises with T.E.N.s tend to act as a 'magnet' to attract customers after 03:00hrs due to there being no alternative premises open. Inevitably, these customers are more intoxicated than they were earlier in the evening and tend to be more 'rowdy', which often leads to more incidents of anti-social behaviour and crimes being committed. Due to a change in force structure to a centralised licensing model caused by limited resources, a practice of authorising such T.E.N.s without wider considerations took place. Having recently commenced my role as Chief Inspector and reviewed both the data, and practices that we have in place, I am now intent upon placing a greater emphasis upon reviewing such T.E.N. applications. I have a responsibility to act in the best interests of the St Helens residents and ensure safe use of the N.T.E. The data presents a clear and emphatic crime pattern and I believe that to grant such T.E.N.s places residents at greater risk of becoming a victim to violent crime.
- 17. Further to the above responsibilities that come with my role, and the data discussed, it is also of upmost importance to highlight the fact that Westfield Street sits prominently in a defined Serious Violence Hot Spot. Such Hot Spot locations are identified through analysis of serious violence data, taking into account offences committed and likelihood of future harm. Dedicated analysts, funded by Home Office, have identified 12 hot spot locations across Merseyside and this is one of them. Such locations are provided Home Office funding to implement problem solving responses and part of the effective response to tackling high levels of serious violence in this locality is the effective management of risk presented by the N.T.E. In order to manage this, we have previously funded improved lighting and

CCTV coverage, along with the purchase of knife wands for Security Industry Authority (S.I.A.) trained door staff. This being the case, it is my duty to take all available opportunities to reduce risk and tackle serious violence.

- 18. As can be seen from Exhibit JS/03, levels of serious violence for St Helens are at their highest in D111 beat, with there having been 26 instances in the twelve months prior to this statement. D112, which is also in the Town Centre, is second and had 18. Westfield Street is again the street with the highest level of serious violence, having experienced 5 crimes over the twelve month period; 3 of which took place between the hours of 03:00-06:00hrs
- 19. It is my assertion that the extension of these licensing hours will be counter-productive to the work we have undertaken, and continue to do, in order to make this area a safer place for patrons. Such increased licensing hours, in my opinion, contribute to increased risks to the wider community and a greater likelihood of alcohol or drug related violence.
- 20. Due to the prevalence of anti-social behaviour, crime and disorder occurring in the Town Centre ward generally, Merseyside Police, alongside Community Safety, submitted evidence in support of a Cumulative Impact Assessment to St Helens Council. I understand the Cumulative Impact Assessment has been exhibited elsewhere.
- 21. The evidence submitted to St Helens Council highlighted a number of specific streets where anti-social behaviour, crime and disorder were proportionally higher than elsewhere in the borough. Westfield Street, the location of Bar 44, was highlighted as such a street.
- 22. I understand the Cumulative Impact Assessment was subsequently approved by St Helens Council, focused on four specific streets including Westfield Street. This reinforces my belief that there is sufficient evidence to demonstrate significant issues faced in this area.
