103 DECLARATIONS OF INTEREST FROM MEMBERS

No Declarations of Interest from Members were made.

104 <u>PARKSIDE REGENERATION LLP MANAGEMENT BOARD – CHANGE OF</u> <u>APPOINTMENT</u>

A report was submitted which sought to approve a change in the appointment of the Council's representative members of the Parkside Regeneration LLP Management Board.

In 2013 the Council entered into a 50/50 joint venture with Langtree Land and Property PLC. Parkside Regeneration LLP was established as the vehicle through which the former Parkside Colliery site would be acquired and developed.

Parkside Regeneration LLP was controlled by a six-member Management Board; comprising three members from Langtree and three members from the Council. The three Council appointees were the Cabinet Member for Economy, Business and Skills, the Executive Director of Place Services and the Chief Executive.

It was proposed the Executive Director of Corporate Services replaced the Chief Executive with immediate effect. The Executive Director of Corporate Services had previously served as a Board Member on the Parkside Regeneration LLP Management Board.

 - (1) the appointment of the Executive Director of Corporate Services to the Parkside Regeneration LLP Management Board with immediate effect to replace the Chief Executive be confirmed.

105 ADOPTION OF SUPPLEMENTARY PLANNING DOCUMENTS

A report was submitted which provided an overview of the consultation process undertaken and feedback received on the first tranche of new Supplementary Planning Documents and sought approval for adoption of their final versions, which would help guide and shape the growth of the Borough in support of the St Helens Borough Local Plan up to 2037.

The St Helens Borough Local Plan up to 2037 was adopted by the Council in July 2022 and, to aid its positive ongoing implementation, four new first tranche Supplementary Planning Documents had been prepared that provided additional details and planning guidance.

The report presented the final versions of these documents (following a consultation period as detailed within the Consultation Statement), each of which would have a pivotal role in the successful delivery of high-quality developments in accordance with the Local Plan up to 2037.

* Resolved that:

- (1) the Supplementary Planning Documents Consultation Statement at Appendix A be noted; and
- (2) the final Supplementary Planning Documents for Design, Developer Contributions, Open Space Provision and Enhancement, and Transport and Travel at Appendices B to E respectively be approved for adoption.

106 <u>DEVELOPMENT OF 'ITS OUR BOROUGH TOO' ST HELENS BOROUGH</u> <u>CHILDREN AND YOUNG PEOPLE'S DECLARATION</u>

A report was submitted which informed Cabinet that over the past year, in partnership with the Youth Council, Vibe and other local youth organisations, officers have engaged with thousands of young people from all different backgrounds to co-produce *'It's Our Borough Too'*. This document outlined their priorities and their vision for a better, more child friendly borough and outlined the Council's, local partner's and young people's collective commitments to delivering this over the next three years.

This was a live document and a number of amendments had already been identified for further consideration which were included in the report.

Cabinet was informed that the decision was a Key Decision and details had been published in accordance with the provisions within the Constitution.

107 <u>CARE AND SUPPORT SERVICES IN EXTRA CARE RETENDER – FOUNDRY</u> WHARF, HEALD FARM COURT, REEVE COURT AND HEYESWOOD

A report was submitted which informed Cabinet that the current Extra Care contracts for the care and support provided to all four schemes was to expire on 31 July 2024.

The Council holds the responsibility to ensure a sufficient supply of care and support services in the local area, supporting the key principles in the Care Act 2014 outlining market sustainability and supporting a preventative approach. The Council were committed to providing good safe value for money services that met the needs of the local population. The Council was responsible for maintaining a stable care market and evidence value for money. The proposal outlined for supporting alternative options of care ensured the Council was meeting the core asks with in the Care Act 2014

Cabinet was informed that the decision was a Key Decision and details had been published in accordance with the provisions within the Constitution.

 - (1) the contents of the report and the commission of care and support within the four Extra Care residential units be noted;

 - (3) the Head of Legal and Democratic Services be authorised to execute the necessary legal documentation to put into effect the arrangements as set out above; and
 - (4) the approach to change the model of Extra Care to a 'core + flexi model' and to move towards the balance of care model over a period 3 years with an option to extend for a further 2 years be approved.
